Major Changes for Broadway

Broadway between 96th and 110th Streets appears slated for major and dramatic changes, raising concerns for neighborhood leaders and politicians. In this section of Broadway, there are 13 two-or three-story buildings. Two of them—the Olympia Theatre at 107th and the D'Agostino building—are already targeted for replacement by 25+ story buildings. The buildings in our neighborhood generally have 16 stories (315 RSD at 20 stories and 310 RSD at 24 stories are two rare exceptions. Look for more on the redevelopment issue in future newsletters and in the local press. What do you think about the redevelopment of Broadway? Let any board member know.

On a somewhat related matter, yet another major drug chain is moving into the neighborhood. This time it's CVS which has apparently signed a lease for the former Associated Supermarket space between 102nd and 103rd Streets. This puts it directly opposite a Duane Reade, and one block away from Rite Aid and Suba Pharmaceuticals, the lone independent pharmacy in our neighborhood. 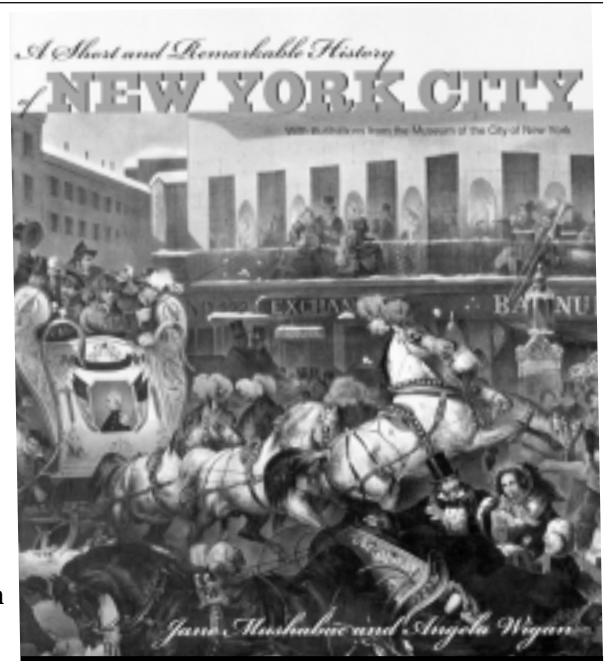

Leash Laws: Chapters and Verses

Just what you always wanted to know: the NYC leash law! New York City Health Code 161.05 reads: "A person who owns, possesses, or controls a dog shall not permit it to be in any public place or in any open or unfenced area abutting on a public place unless the dog is restrained by a leash or chain not more than six feet long." Translation: leash your dog in public!

Slightly different leash rules apply in City parks. Park regulations state that dogs must be leashed (1-04(i)) except in dog runs (105(s)(3)). Additionally, in Riverside Park, the commissioner, who owns Boomer, a golden retriever, has permitted dogs to be off the leash between 9:00 p.m. and 9:00 a.m. (that's evening through early morning), except where posted signs prohibit off-leash dogs. Enjoy your pet!

Danger Ahead: Asian Longhorned Beetle

Enclosed with this newsletter is a Pest Alert from the US Forest Service on the Asian Longhorned Beetle, the biggest threat to North American trees since Dutch Elm disease wiped out American Elm trees in the fifties. We urge you to read the alert thoroughly and actively engage yourself and your family in the fight against the beetle. Observe our maple, sycamore, and elm trees for signs of the devastating disease and immediately call **1 800 201 PARK** when you see them

I called Kevin Kenny at Bartlett Tree Service, the company that had recently fertilized the trees on our block. Kevin said the tree was suffering from an early April frost and that it would soon recover and relauf. Kevin explained that trees, like people, are highly individualistic and one tree in a grove could behave quite differently from its neighbors. Sure enough, the ailing tree soon grew a new canopy of healthy leaves and is now doing just fine, thank you.

105th Street Dog Run Improved

The refurbished dog run at 105th St. is a prime example of a public/private partnership among the Riverside Park Fund, the Parks Department, and D.O.G. (Dog Owners Group) of Riverside Park. The \$75,000 project included a double-gated entry; a central play area of compacted, crushed brownstone; an outer dog run of wood chips; a separate area for small dogs; World's Fair benches, and new plantings. Outdoor Grilling Etiquette

There's nothing like great tasting bar-b-que! In the city, however, outdoor grilling is subject to a stringent law and is the source of noxious fumes. Under New York City fire code rules, grills must be 10 feet from combustible material, including trees. Few places on our block meet this ten-foot rule. In addition, using lighter fluid in the confined space of a city backyard means your neighbors must endure its noxious smell. (The block association will reduce its use of lighter fluid at the September 16 Yard Sale.)

Summertime and the Livin' Is Easy

Summertime brings both pleasures and issues of concern to city dwellers. Below are three items to help make the warm months a pleasure for all residents.

Safety Tip: Installing Air Conditioners

Please keep safety—yours and others'—first when installing your air conditioner this summer. Never install or remove an air conditioner by yourself, no matter how small it is or how many times you've done the job alone before. Check with your super about your building's rules; you may need to have him review and approve an installation done without the help of building staff.

Outdoor Entertaining Etiquette

To residents with outdoor living spaces. When you entertain outdoors, be aware that your conversation and music is experienced not just by your invited guests but by your neighbors, too. Your sounds are amplified by the surrounding buildings and sent floating upward to the apartments that overlook your backyard or terrace. Please do the neighborly thing and move your party indoors after 11:00 p.m.


To residents bothered by late-night outdoor parties. What can you do about the noise? Close your windows, use ear-plugs, meditate it away (yeah, right), or call the precinct (**678 1811**) with the address of the party. The police will tell the host that there have been noise complaints. The more complaints the police get, the more seriously they will treat them.
